In 2017, as part of a strategic realignment, Dr. Ulrich Kienitz, the founder and majority owner, acquired all remaining business shares once owned by Micro-Epsilon, to ensure continued reinvestment in the company's future growth.

The decision to end the sales partnership today was made by mutual agreement as both companies are now focusing on their respective core businesses.

Dr. Sascha Kienitz, who succeeded his father, Dr. Ulrich Kienitz, remarked on the decision: *"As both parties pursue new strategic directions and concentrate on their core competencies, it feels like the right time to embrace new challenges and opportunities independently."*
